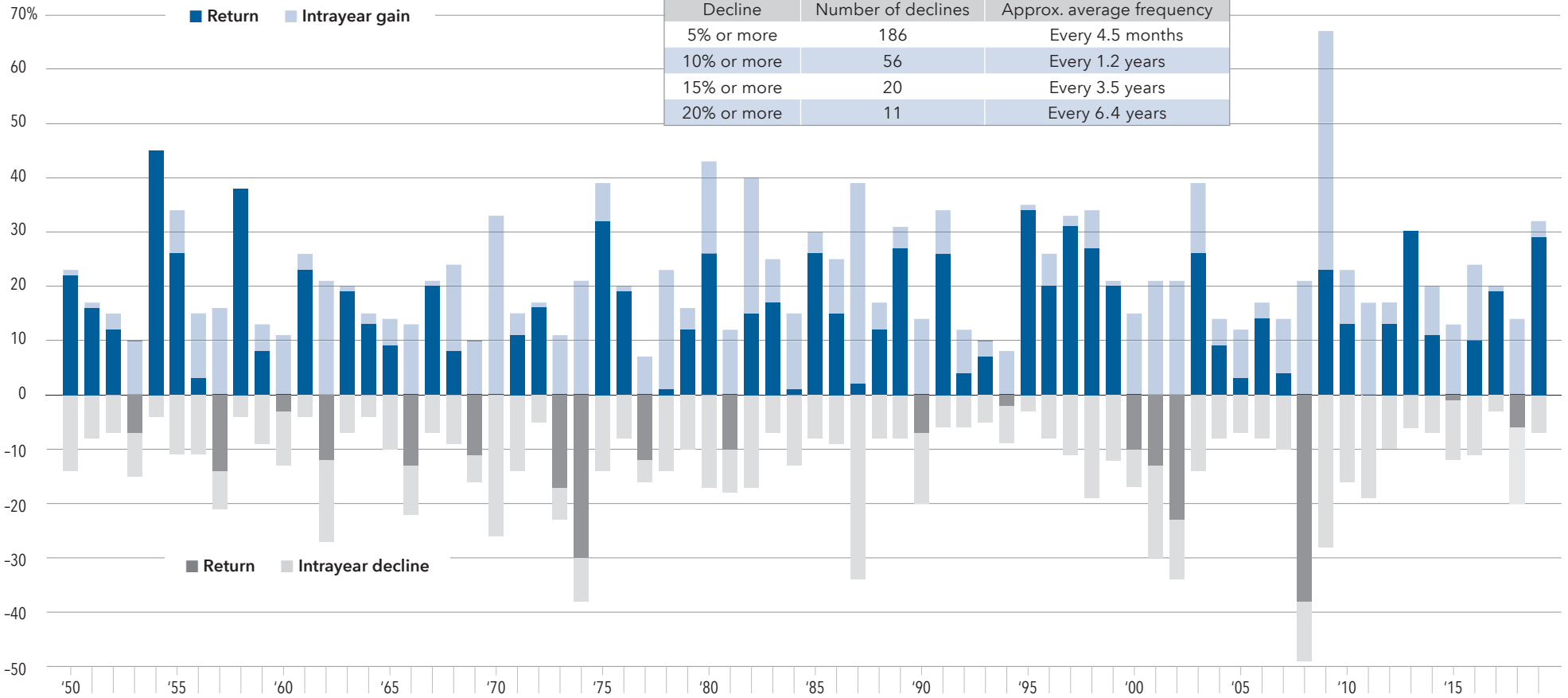




Intrayear declines in the S&P 500 have averaged 13.4% since 1950, yet annual price returns have been positive in 51 of those 70 calendar years.
